1. Introduction

This is the Privacy Statement and Data Retention Policy ("Privacy Policy") for **DOOMS PRINTERS (Pty)LTD**. This Privacy Policy was last updated in January 2021.

DOOMS PRINTERS is committed to protecting your personal information you provide to us or when you access and use materials on www.doomsprinters.co.za (the "Website"), including the Website subscription pages or other websites or apps that post a link to this Privacy Policy. Information that you submit to **DOOMS PRINTERS** in response to an email request for information or other outreach from **DOOMS PRINTERS**, or through **DOOMS PRINTERS** contract and casual employment application processes, will be treated in accordance with this Privacy Policy. Whenever you provide such information we will only use your information in line with all applicable data protection laws, including the Financial Intelligence Centre Act (FICA), Your information will be kept in a secure environment electronically and safe place and access to it will be restricted according to the 'need to know' principle. Approval to information will be authorized by senior manager.

DOOMS PRINTERS may, in its discretion, amend this Privacy Policy from time to time. To ensure you are able to remain informed about the information we collect and how we use it, material changes to our statement will be reflected here website. 2. Your Acceptance of this Privacy Policy

Please read this Privacy Policy carefully. By browsing our Website and expressly consenting where required, you agree to be bound by this Privacy Policy.

3. What Information Do We Collect?

DOOMS PRINTERS collects information from you when you upload your personal information and documents for the Website, request copies of publications, subscribe for email newsletters and press releases, seek additional information regarding our services or employment opportunities, databases, or register for conferences and other **DOOMS PRINTERS** -sponsored events. If you do not provide such information, you will not be able to fill the form for the Website, request copies of publications, subscribe for email newsletters and press releases, seek additional information regarding our services or employment opportunities.

Personal information that we collect includes: names, addresses, e-mail addresses, phone numbers, unique personal identifiers, financial information, subject areas of interest and/or demographic information.

In addition, **DOOMS PRINTERS** may also conduct user surveys on the Web or use technologies to provide **DOOMS PRINTERS** with information on a number of areas, such as user identity, user viewing habits, whether or not users found what they were searching for, whether the Website content is relevant to user needs, and the like.

4. What Information Do We Collect?

The purposes and uses of your personal information will depend on the use of the Website and the personal information provided. We process your personal information:

- For the purposes of safeguarding DOOMS PRINTERS legitimate interests, including:
- Informing you about updates to our services and notifying you about other products and services offered by **DOOMS PRINTERS** that may be of interest to you, including information regarding publications and events or sending you marketing materials;
- Responding to feedback, queries and complaints that you submit to us;

- Measuring and improving the effectiveness of DOOMS PRINTERS marketing actions across different channels:

- Improving our web content and navigation.
- On the basis of your consent. Insofar as you have granted us consent to the processing of personal information for specific purposes, the lawfulness of such processing is based on your consent. You may withdraw your consent at any time.
- For compliance with a legal obligation. This includes anti-fraud and anti-money laundering measures as well as tax and social security requirements as required by Financial Intelligence Centre Act (**FICA**).

5. How We Might Share Your Information

DOOMS PRINTERS will not sell, share, or rent or otherwise make available your personal information to other parties, except that we may disclose the information to third parties who perform services on our behalf and have a need to access the information in connection with those services. Any third parties will only process this information to the extent to which and within the limits that **DOOMS PRINTERS** itself is permitted to process that data. In addition, **DOOMS PRINTERS** may disclose your contact information in response to inquiries by bona-fide rights owners in connection with allegations of infringement of copyright or other proprietary rights arising from information that you have posted on the Website or otherwise provided to **DOOMS PRINTERS**.

The third parties with whom we may need to share personal information to help us provide services and products to you and to run our Website include: our partners or affiliates; our advisors; our third party service providers who process information on our behalf to help run some of our internal business operations including email distribution, IT services and marketing and events services; our business partners for publications and events co-organized by **DOOMS PRINTERS** and them; law enforcement bodies in order to comply with any legal obligation or court order.

The above also includes third parties located in different countries around the world, including outside of the boarders of the Republic of South Africa. We only make these arrangements or transfers where we are satisfied that adequate levels of protection are in place to protect information held in that country. In addition, the Website may be viewed and accessed anywhere in the world, including countries that may not have laws regulating the use and transfer of personally identifiable information. By using the Website, submitting information through the Website, or submitting personal information to **DOOMS PRINTERS** through other means, you voluntarily consent to such international transfer and hosting of such information to those countries and parties.

6. Retention of Your Personal Information

DOOMS PRINTERS retains your personal information for as long as is necessary to fulfill the purpose for which it was collected. We may retain your personal information for longer if it may be the subject of a legal claim, or may otherwise be relevant for future litigation.

Performance: These cookies are used to collect anonymous information about how you use our Website.
